Askew's Food Service Ltd and Askew's Foods (Sicamous) Ltd. (the chain) did not have any active policies or procedures in place for the 2023 reporting year to mitigate the risks of forced labour or child labour in its local or international supply chains.

Section 11(3)

 a) Askews Food Service Ltd. and Askews Foods (Sicamous) Ltd. are privately held corporations. The chain operates 5 full service grocery stores in the North Okanagan. The stores operate autonomously taking advantage of collectively strong relationships with its large vendors and small vendors to remain competitive in the market and support local suppliers. Sourcing of goods is done at the store level (not centralized) with individual departments (i.e. grocery, meat, produce, dairy etc.) responsible for managing inventory and supply. The stores supply chains consist of local vendors and artisans offering fresh produce, meats and baking and extend to larger vendors importing a wide range of both domestic and international products. The chain does not directly import any product from outside Canada. All vendors are resident in Canada. The chain employs between 360 – 380 employees. The chain is a member of the Canadian Federation of Independent Grocers.

- b) The chain did not have any policies or due diligence processes in place to mitigate risk of forced labour or child labour in its operations or supply chains.
- c) Elevated risk of forced and child labour could exist with any goods imported from outside the North Okanagan locale. Currently no steps have been taken to assess or manage these risks nor is management aware of any risks.
- d) No measures have been taken to remediate forced or child labour.
- e) No measures have been taken to remediate the loss of income to vulnerable families or persons in any of the existing supply chains.
- f) No training has been provided to employees regarding forced or child labour.
- g) The chain currently has no processes in place to assess any effectiveness of policies and procedures aimed at mitigating the risk of forced or child labour.
